Dear Senator Graham,

It is my honor to inform you that your name will be placed on the March 1, 2016 Tennessee Presidential Preference Primary ballot as a nationally recognized candidate for the Republican Party unless a withdrawal affidavit is filed pursuant to Tennessee Code Annotated § 2-5-205(b) and § 2-13-304(b).

For your name not to appear on the March 1, 2016, ballot, you are required by statute to file an affidavit stating that "without qualification" you do not intend to become a candidate for President in the forthcoming presidential election. This sworn affidavit must be in writing, signed by the candidate, and filed with the State Election Commission and the Secretary of State's office no later than twelve o'clock (12:00) noon, Central Standard Time, on December 8, 2015. You may mail the affidavit to: Tennessee Division of Elections, 312 Rosa L. Parks Avenue, 7th Floor, Nashville, Tennessee 37243-0305.

Dear Senator Graham:

Michigan will conduct a Presidential Primary on Tuesday, March 8, 2016. In preparation for the Presidential Primary, I am required to issue a list of "individuals generally advocated by the national news media to be potential presidential candidates" for both the Republican and Democratic Parties. MCL 168.614a. The chairpersons of Michigan's Republican and Democratic Parties are similarly required to provide "a list of individuals whom they consider to be potential presidential candidates" for their respective parties. *Id.* All of the lists have now been filed. I write to inform you that your name was placed on one or more of these lists (see www.michigan.gov/elections).

The placement of your name on the above-referenced list(s) automatically qualifies you for Michigan's March 8, 2016 Presidential Primary ballot; no further action on your part is required. The following options, however, are available:

- If you do not wish to appear on Michigan's Presidential Primary ballot, you may withdraw by filing a sworn statement, executed by you and witnessed by a notary public, expressing your desire to have your name removed from the ballot. If you wish to avail yourself of this option, you must, "file an affidavit with the secretary of state specifically stating that '(candidate's name) is not a presidential candidate', and the secretary of state shall not have that presidential candidate's name printed on a presidential primary ballot." MCL 168.615a. The affidavit must be received in the office of the Michigan Department of State's Bureau of Elections no later than 4:00 p.m. (E.S.T.) on Friday, December 11, 2015.
- If you wish to express a preference for a political party which differs from the party designation assigned to you on the above-referenced list or wish to declare that you have "no political party preference," you may effect such a change by filing a sworn statement, executed by you and witnessed by a notary public, which states your interest in altering your party designation. *Id.* The affidavit must be received in the office of the Michigan Department of State's Bureau of Elections no later than 4:00 p.m. (E.S.T.) on Friday, December 11, 2015. (The Republican Party and the Democratic Party are the only political parties that are qualified to participate in Michigan's Presidential Primary. Consequently, if you express a preference for a party other than the Republican Party or the Democratic Party

or declare that you have “no political party preference”, your name will not be printed on Michigan’s Presidential Primary ballot.)

- If you wish to participate in Michigan’s Presidential Primary but wish to have your name appear on the ballot in a form other than the form shown on the above-referenced list (“**Lindsey Graham**”), you may modify the form of your name by submitting a written request to this effect. If you wish to request a modification, please notify the Michigan Department of State’s Bureau of Elections in writing no later than 4:00 p.m. (E.S.T.) on Friday, December 11, 2015.




