Dear Governor O'Malley,

It is my honor to inform you that your name will be placed on the March 1, 2016 Tennessee Presidential Preference Primary ballot as a nationally recognized candidate for the Democratic Party unless a withdrawal affidavit is filed pursuant to Tennessee Code Annotated § 2-5-205(b) and § 2-13-304(b).

For your name not to appear on the March 1, 2016, ballot, you are required by statute to file an affidavit stating that "without qualification" you do not intend to become a candidate for President in the forthcoming presidential election. This sworn affidavit must be in writing, signed by the candidate, and filed with the State Election Commission and the Secretary of State's office no later than twelve o'clock (12:00) noon, Central Standard Time, on December 8, 2015. You may mail the affidavit to: Tennessee Division of Elections, 312 Rosa L. Parks Avenue, 7th Floor, Nashville, Tennessee 37243-0305.
