

1 Plaintiff has filed a statutory action for injunction (nomination petition challenge) which
2 challenges the candidacy of the real party in interest, Edna San Miguel, a person seeking
3 nomination for U.S. Representative for Congressional District 3. A.R.S. § 351(A), requires this
4 court to hear and render a decision within 10 days after the filing of this challenge.

5 IT IS HEREBY ORDERED that defendants, including real party in interest Edna San
6 Miguel shall appear before this Court 15th day of June, 2016 at 1:30 o'clock P.m.,
7 before the Honorable Woods, Judge of the Superior Court, Court room 583 located
8 at 110 West Congress Street, Tucson, Arizona 85701 to show cause why the injunction requested
9 for a status conference and/or
10 contained in the Complaint in this matter should not be granted. This setting is for the
11 consideration, hearing, trial and determination of the statutory relief requested in the Complaint.

12 IT IS FURTHER ORDERED that plaintiff is directed, pursuant to A.R.S. §16-351(D), to
13 immediately serve copies of process of the lawsuit including this order upon Arizona Secretary
14 of State Michelle Reagan, as statutory agent appointed to receive process for all parties, but in no
15 event more than twenty-four hours after filing this action. Plaintiff's service upon the Arizona
16 Secretary of State constitutes compliance with all service of process obligations under the statute,
17 and all parties will be deemed served, and the Arizona Secretary of State will notify the person.

18 YOU ARE HEREBY NOTIFIED that if you fail to appear and defend in the above court
19 on the date and time set above, a judgment, order and/or relief demanded in the Complaint may
20 be rendered against you.
